# STUDENT HANDBOOK

### Introduction

Denison University is an educational community that prizes intellectual excellence and integrity. At Denison, students participate in an academic experience under the guidance of a faculty deeply devoted to teaching and actively engaged in advanced research and scholarship. The residential nature of this community permits learning to continue beyond the classroom.

Denison regards its students as moral agents who are capable of assuming primary responsibility for conducting their lives and making their decisions. Central to the mission of the University is the continual development of a community of respect, in which the principles of human dignity and ethical integrity are paramount. Rational dialogue and discourse determine the character of our interaction with each other.

Denison expects all members of the academic community to engage each other with mutual respect, compassion, and a deep appreciation for all of the cultural, racial, ethnic, sexual, religious, and economic differences that comprise the richness of our community.

The Student Handbook is not a contract. It is provided with the intention of including in one location current information and resources for student life at Denison. In it, you will find a description of the various offices, services, and resources, as well as the policies and regulations that govern life at the University. All students are responsible for reading and knowing the policies and regulations of the University.

As you embark upon your collegiate journey at Denison, we trust that this Handbook will serve you well as a guide.

### **Notices of Non-Discrimination**

### **Statement on Academic Freedom**

Denison University actively promotes the free expression and exchange of ideas. Academic freedom is essential to the aims of higher education and to the University's goals of fostering critical thinking, moral discernment, and active citizenship among its members. It is the responsibility of the faculty and the administration to protect academic freedom. Furthermore, because Denison is a residential, liberal arts college, academic freedom must be extended to all members of the university community in the broadest of contexts. Indeed, academic freedom is a core value of liberal education and is essential to the transformative power of that education promised in our mission statement.

Academic freedom is the right of all members of the University to exercise the broadest possible latitude in speaking, writing, listening, challenging, and learning. It applies to opinions and inquiry regarding political, cultural, religious, scientific, and social matters, as well as to those regarding the University itself and its policies. Academic freedom is especially critical in the classroom, in research and publication, and in all educational activities.

Academic freedom applies to views and ideas that most members of the University may consider mistaken, dangerous, and even despicable. The ideas of different members of the University community will often conflict, but it is not the proper role of the University to shield individuals from ideas and opinions they find unwelcome, disagreeable, or offensive. Although the University values civility, and although all members of the University community share the responsibility for maintaining a climate of mutual respect, concerns about civility and mutual respect can never be used as a justification for limiting discussion of ideas, however offensive or disagreeable those ideas may be to some members of the community.

Academic freedom does not, of course, mean that individuals may say whatever they wish, whenever they wish. The University may prohibit expression that violates the law, defames specific individuals, constitutes a genuine threat or harassment, or unjustifiably invades substantial privacy or confidentiality interests. These limitations, however, are narrow exceptions; it is vitally important that these exceptions never be used in a manner that is inconsistent with the University's commitment to a free expression of ideas.

Members of the University community must act in conformity with the principle of academic freedom. Although members of the University community are free to criticize and contest the views of others, they may not obstruct or otherwise interfere with the freedom of others to express views they reject. To this end, the University has a solemn responsibility not only to promote a lively and fearless freedom of debate and deliberation, but also to protect that freedom when others attempt to restrict it. Such an open exchange of ideas is essential to liberal education.

### The Center for Global Programs

The Center for Global Programs develops core elements of a global experience for Denisonians through off-campus study, international student support, multilingual learning, intercultural residential living, and community engagement. By encouraging dialogue across differences, we foster global citizenship, locally and abroad, fulfilling Denison's mission of building discerning moral agents, autonomous thinkers, and active citizens as part of a liberal arts education.

The Center for Global Programs (CfGP) is Denison's global experiences hub. It houses off-campus study operations, support for international students, and multilingual learning initiatives. It collaborates regularly with the Lisska Center for Scholarly Engagement, the Knowlton Center for Career Exploration, academic departments and programs, the Division of Student Life, and other campus partners to expand global learning pathways and approaches. Our growing international community on campus includes students from around the world, permanent residents who live abroad, US citizens, and individuals who identify as global citizens. The CfGP also facilitates the Global Living Community, a unique opportunity for students to live in a residence hall with other globally-minded peers and expand their world perspective outside

### **Off-Campus Study**

Off-Campus study provides dynamic experiences worldwide to improve global competency, gain experience to build a resume, and find passion through hands-on learning. Students who study off campus come from various majors, interests, personal and financial backgrounds, and academic and extra-curricular involvement levels at Denison. More than half of the student body participates in off-campus study, including faculty-led travel, at some point during their four years, with the majority doing so during their junior year. The Center maintains a list of hundreds of approved programs in dozens of countries worldwide, including the United States. ### **International Student Support**

The ISS team provides support for our international students so that they can thrive in their classes, develop friendships on campus, and participate in various co- and extracurricular opportunities. We support students during their arrival to campus; regular one-on-one advising on the academic, social, and personal challenges associated with living and learning in an unfamiliar culture; career exploration advising; and continuing education focusing on immigration regulations and requirements pertaining to the nonimmigrant student visa. The Denison ISS Portal (http://ocsdenison.inbound.via-trm.com) houses valuable information on maintaining the F-1 student visa status, employment options, ID cards, and more.

### **Multilingual Learning**

The Multilingual Learning staff supports the academic success and achievement of all Denisonians working in multiple languages through one-on-one tutoring and consulting sessions, group workshops, and the creation of online resources. If English is not a student's first language, our staff can assist with writing, reading, note-taking, and presentation skills. In addition, a Writing 101 (W101) course is offered by our Assistant Director, Multilingual Programming and Support or English Language Support Specialist to international students during their first year enrolled at Denison. The course is designed to assist multilingual students in developing their college writing skills across various subject areas.

### **Lisska Center for Intellectual Engagement**

The mission of the Lisska Center for Intellectual Engagement is to support research and scholarship, to foster intellectual community and academic enrichment among all Denisonians, and to provide an interdisciplinary space for the open exchange of ideas, perspectives, and arguments.

The Lisska Center is a dynamic space where intellectual curiosity is celebrated and diverse perspectives collide to spark exciting new ideas. Whether you're interested in conducting cutting-edge research, pursuing academic opportunities off-campus, or attending thought-provoking events, the Lisska Center has something to offer to students across all majors and class years.

With a highly experienced staff passionate about supporting students' academic growth and success, both inside and outside the classroom, the Lisska Center offers advising to those interested in applying for fellowships and external awards, opening doors to exciting opportunities worldwide. These fellowships can fund time abroad, a research or community-centered project, or graduate education. All students and recent graduates are encouraged to take part in individual fellowship advising to learn about awards that would be a good match based on their particular interests and goals. The Lisska Center can offer advice on how to best position students as strong fellowship candidates. The Lisska Center hosts fellowship information sessions throughout the year and offers full support on all aspects of fellowship applications, such as writing personal statements and preparing for interviews. The Lisska Center ensures that the process of applying for fellowships is a valuable educational experience regardless of the application outcome.

The Lisska Center also coordinates the Summer Scholars Program. This prestigious, award-winning initiative allows students to collaborate with Denison faculty members and conduct groundbreaking research or creative work in their chosen fields. Summer Scholars opportunities are available for ten weeks and five weeks during the summer. Qualified students who are rising sophomores, juniors, and seniors in all disciplines are eligible to apply for Summer Scholars awards.

The Lisska Center is home to the Denison Scholar-Leader program. The Scholar-Leader First-Year Advising Experience is a community of first-year students who have an identifiable interest in leadership, academic enrichment, and selective fellowship opportunities. These courses provide a foundation of skills and experiences in preparation for leadership, scholarship, and service. In the first semester, students develop personal and professional skills that support a healthy transition to college. Students reflect on their values and goals to shape their career exploration and identify areas of potential academic scholarship and leadership impact. In the second semester, students focus on developing leadership and networking skills and exploring competitive fellowships, internships, and research opportunities. The Scholar-Leader First-Year Advising Experience includes the pre-orientation trip called Exordium (The Beginning) before fall classes.

The Scholar-Leader Sophomore Experience is a sequence of courses for sophomores that develops academic enrichment, leadership, civic engagement, and scholarship skills and emphasizes collaborative problem-solving. In the fall, students learn and assess their strengths and engage in experiential learning focused on exploring and researching expressed needs, whether on campus, in the community, or beyond. Students work in small groups to research those needs and network

with leaders to learn about available services and potential areas for partnership. Successful completion of the fall course enables students to progress into the spring course, where they choose a pathway or project based on their research and networking experience. The goal is for students to channel their creativity and experience into a concrete plan that they work on together to design potential community solutions. Examples include the design of a project to address a specific need, a polished group application to a granting agency or other opportunity, a planned event, and so on. Students may enroll in the Scholar-Leader Project in their junior and senior years to move their projects to an implementation stage and continue to work collaboratively on their outcome.

If you're eager to explore academic experiences beyond the classroom, the Lisska Center can help fund your travel expenses and research supplies, making it easier to pursue your passions. At the heart of the Lisska Center's mission is a commitment to creating a culture of intellectual life on campus. The Minds Wide Open series brings together modern thought leaders to share their ideas and perspectives on a wide range of topics. # Office of Community Values & Student Conduct

The Office of Community Values and Student Conduct (OCVSC) oversees the Code of Student Conduct. It facilitates processes for both individual and organizational groups grounded in fair, equitable, and educational approaches. Individuals are provided the opportunity to navigate through accountability processes by addressing their involvement in situations, identifying their role or responsibility in a situation, and engaging in outcomes that help remedy the impacts of their decision-making on the community. Staff provide conflict coaching, education, and programmatic connections to campus and community resources to support the connection between individual behaviors, values-based decision-making, and community well-being.

Beyond formal student conduct processes, OCVSC staff provide opportunities for individuals to engage in conflict management strategies, either through independent coaching or facilitated mediations. In doing so, staff facilitate learning, redress of harm, and create a deeper meaning of community.

If a student feels that a course grade was the result of a prejudiced, capricious, or in some other way unjust evaluation on the part of an instructor, that student may file a grievance petition with the Academic Standing Board. ### **Disability Grievance Procedures**

For Section 504 of the Rehabilitation Act of 1973 and the Americans with Disabilities Act of 1990.

Through policy and practice, Denison University is committed to providing to all enrolled students equal access to campus programs, services and activities. The following procedures have been adopted to ensure and maintain the University compliance with Section 504 of the Rehabilitation Act of 1973 and the Americans with Disabilities Act (ADA) of 1990 under which no qualified student with a disability shall be denied access to or participation in programs, services or activities of Denison University. A qualified student is defined as one who meets the requisite academic and technical standards required for admission or participation in a postsecondary institution's programs and activities. A person with a disability is anyone with a physical or mental impairment that substantially limits one or more major life activities, such as walking, seeing, hearing, speaking or learning. In addition to those people who have visible disabilities, the definition includes people with a whole range of invisible disabilities. These include psychological disabilities, learning

disabilities, or some chronic health impairments such as epilepsy, diabetes, lupus, cancer, HIV/AIDS, and more.

# **Anti-Harassment Policy**

The term "harassment" in this policy refers to unwelcome behavior that is offensive and sufficiently severe or pervasive that it interferes with, or limits the ability of, another individual to participate in or benefit from the services, activities, or privileges provided by the university, or creates an intimidating, hostile, or abusive working, living, or learning environment.

It is the policy of Denison University, to be read in context with the important principles regarding academic freedom, that all students, faculty, staff, and visitors should be free from harassment in any form — physical, verbal, graphic, written, or otherwise — based upon an individual's race, color, religion, ethnic or national origin, age, disability, sex, gender, gender identity, gender expression, sexual orientation, veteran status, or any other bases prohibited by law. This policy extends to conduct on university property or off university property if the conduct occurred in connection with a university or university-sponsored event program or activity or the conduct has or reasonably may have the effect of creating a hostile educational or work environment for a member of the university community.

Any member of the university community who believes that they have been the victim of conduct or has witnessed conduct that violates the Anti-Harassment Policy is encouraged to report the matter to a responsible university official: Office of Human Resources, Director of Civil Rights & Title IX (Title IX Coordinator), Dean of Student Life, or the Associate Provost for Diversity Equity and Inclusion.

### **Business and Commercial Activities**

Denison University strives to provide an environment conducive to academic endeavors and co-curricular activities, including entrepreneurial activities. For students with existing businesses or nonprofits and those with new ideas for a business or nonprofit, the Red Frame Lab is your source of support, connections to resources, and mentors.

Denison encourages students to explore entrepreneurship in a variety of forms, particularly when connected to Denison's mission. In pursuing entrepreneurial activities, students must comply with University rules and coordinate their activities with the Red Frame Lab. Student ventures cannot violate the university's Housing Policy and Denison's Code of Student Conduct and be unlawful or disruptive to other students or the campus.

### **Individual Denison Community Members**

The following guidelines should be followed by individuals interested in fundraising or sponsoring business activities on campus:

- Responsibility: All student businesses or non-profit organizations are the student's responsibility. Denison does not provide all applicable insurance, tax, legal, and incorporation requirements. However, the Red Frame Lab employees can help student entrepreneurs think through these aspects of their business venture.
- 2. Approval: Students must communicate with Red Frame Lab employees regarding the existence and nature of their business or non-profit via email and in-person meetings. All paperwork, policies, forms, and procedures necessary for operating a student-run business or non-profit on campus must be obtained from Red Frame Lab and, when completed, reviewed with Red Frame Lab employees. The Red Frame Lab will provide authorization for community members to continue pursuing their activity and keep a record of that authorization.
- Intellectual Property: Any use of Denison intellectual property, including logos, trademarks, and copyrights outside of classes or programs, is subject to standard intellectual property use restrictions. Use associated with classes and programs is subject to review by those advisors.
- 4. Residence Hall Use: Students may operate businesses on campus and/or out of their residence hall rooms so long as no activity violates individual residence hall rules or residence hall quiet hours, does not

violate the university's housing policy, does not interfere with other students' use of the residence hall, does not disrupt the campus, and does not violate other university policies not listed here.

- 5. Receiving and Shipping: The University mail room is for personal packages and is within reasonable personal use. All students operating a business on campus must meet with the Assistant Director for Business Services (the mailroom Director) before beginning to receive or ship anything more than personal items.
- 6. Space: Students operating a business or non-profit may utilize University facilities (such as a residence hall room) once the Red Frame Lab authorization is obtained. Use of university space will be determined on a case-by-case basis. There is no guarantee space will be made available. Students engaged in academically sanctioned businesses through a class or program may utilize facilities and services specified and reserved through the class or program.
- 7. Denison Enterprises: Denison Enterprises, a university-sanctioned campus organization, exists to help students start and operate Denison-centric businesses that exist for the sole benefit of the Denison community and not for individual profit. Meet with a Denison Enterprises or Red Frame Lab employees representative to learn more.
- 8. Payment Acceptance Guidelines: Students conducting private businesses must adhere to Payment Card Information Data Security Standards (PCI-DSS) to protect credit cardholders' data. These guidelines are in place to protect Denison from liability for credit card transactions not conducted for university business. If you have any questions regarding this guidance, please contact ITS: helpdesk@denison.edu
  - a. Credit card transactions may not occur on university-owned devices. Personal computers, phones, or point-of-sale devices must be used for such transactions.
  - Credit card transactions may not occur over a university wireless network. Cellular service is required for all in-person, over-thephone, or online transactions.
  - c. Cardholder information that includes the 16-digit account number cannot be physically on campus, in a student's residence hall room, or on a university-owned device.

### **Policy on Firearms**

No person shall possess, carry, store or use a firearm, deadly weapon or dangerous ordinance, as defined in the Ohio Revised Code, in or on university premises, defined as university owned, rented and/or sponsored property, except as allowable under Ohio Law. ## **Policy on Hazing**

Consistent with the Ohio Revised Code, no individual, group, campus organization or team (including intercollegiate and recreation teams) shall conduct or condone hazing activities. Apathy or acquiescence in the presence of hazing is not considered a neutral act; such action violates this policy. Tradition, the intent of such acts, and the express or implied consent of the victim do not constitute valid defenses for violations of the policy.

Ohio anti-hazing law "Collin's Law: Ohio's Anti-Hazing Act" was signed by Governor Mike DeWine on Tuesday, July 6, 2021. The law increases the legal penalties for hazing, creates a statewide curriculum for college students about hazing and requires transparency at the University level to report instances of hazing.

Incoming students are required to complete training through the Enrollment Checklist before arriving on campus; students who choose to join campus organizations must complete supplemental training each academic year.

It is everyone's responsibility to report allegations or concerns surrounding hazing. Students, faculty, staff, and non-Denison affiliated individuals should report directly to Campus Safety in person on Parking Garage Level P1 or by phone at (740)587-6482.

Individuals may also report through Denison's Anonymous Reporting System (https://denison.edu/campus/anti-hazing/reporting-hazing/). However, reports submitted anonymously or with limited information may limit Denison's ability to follow up on a concern. We urge individuals to report as much information as possible and to provide a way for Denison to communicate in follow-up.

Sexual violence has a profound impact on both assault survivors and our community. Our community expects that students who choose to engage in sexual activity do so safely, appropriately, and in a manner that does not violate University Policy and/or the law. Students who attempt to or engage in sexual activity must have affirmative consent from the other person(s). Violations may vary in severity and consist of a range of behavior, including but not limited to non-consensual sexual contact or touching and non-consensual sexual intercourse, including forced sexual intercourse. Allegations of sexual misconduct are subject to the Policy Prohibiting Sex Discrimination, including Sexual Harassment, Sexual Misconduct, Stalking and Retaliation at https://denison.edu/ forms/policy-prohibiting-sex-discrimination (https://denison.edu/forms/ policy-prohibiting-sex-discrimination/), which outlines the University's definitions of consent, force, incapacitation, and other important definitions related to sexual misconduct, as well as procedures used to investigate and resolve alleged violations. Students are responsible for reading and acting in accordance with the policy.

The University provides several flexible, quality spaces in which students can host registered social events. Students can become "Social Event Manager" trained to activate this privilege.

### Student Records

Denison University guarantees full compliance with the provisions of the Family Educational Rights and Privacy Act of 1974. Student educational records are maintained and may be accessed only by members of the University with a legitimate educational interest.

Students may inspect the contents of their official file and placement credentials, including personal references. Exceptions are letters collected under a waiver of inspection and information on parents' financial status. Requests should be in writing to the office responsible for those records, and upon inspection, may not be removed from that office.

The Division of Student Life is the depository for student conduct and disciplinary records. The Provost's office maintains Academic Integrity records. The Registrar's Office maintains all academic information. The Office of Financial Aid maintains all forms and correspondence regarding financial aid, scholarships, and student employment. University Communications maintains information used for news releases to the media.

In addition to the regular sharing of grade information among University offices concerned with student academic standing and advising, cumulative GPAs are furnished to officers of chartered honoraries for membership selection.

Contents of inspected records may be challenged if the information is inaccurate, misleading, or otherwise in violation of the person's privacy or other rights. The administrator responsible for the maintenance of those records will hear the challenge, and based on the information presented, may decide to:

- · Let the record stand
- · Allow the student to insert a letter of explanation

- · Correct the record
- · Delete the item in question
